

RELEASE AND PARTICIPATION AGREEMENT

In consideration of my participation in the documentary to be produced by The University of Maryland, School of Social Work, namely _____ (the "Programs"), and without further compensation to me, I agree as follows:

1. I grant to the University of Maryland, Baltimore ("UMB") together with its employees, agents, licensees, successors, assigns and those acting with UMB's permission or upon its authority, the absolute and irrevocable right and permission:
 - a. To record and use my name, appearance, voice, likeness, personal and health information, and other photographs, digital images, film, tape, and recordings of me, including previously recorded digital images, film, tape, and recordings of me (collectively, my "Images and Story");
 - b. To reproduce, sell, give, transfer, license, broadcast, exhibit, perform and otherwise use my Images and Story as part of works on tape, film, videotape, the Internet, Podcast, still photographs, audiotapes, books, brochures, or any other medium for any purpose and in any manner, including without limitation as part of the Programs; and;
 - c. To reproduce, sell, give, transfer, license, broadcast, exhibit, perform and otherwise use my Images and Story as part of works on tape, film, videotape, the Internet, any animated format, still photographs, audiotapes, books, brochures, or any other medium for any purpose and in any manner, including without limitation as part of the Program; and
 - d. To use, re-use, reproduce, publish, re-publish, distribute copies, and perform my Images and Story and the Program, in whole or in part, individually or in conjunction with other photographs or images, in any medium and for any purpose, including without limitation illustration, promotion, advertising and trade, through any medium and in any and all media now or hereafter known, including without limitation print, broadcast, cable, and Internet;

Provided, however, that my Images and Story may be used by UMB solely for the Program.

2. I waive any rights and claims to royalty payments or other consideration. I give my unrestricted and irrevocable permission for UMB to copyright in its own name, or in any other name, the Program.
3. I waive any right to inspect or approve the finished product or products, the copy or printed matter that may be used in connection with the Images and Story or the Program, or the uses to which the Images and Story and the Program may be applied.
4. I release, discharge, and agree to hold harmless the University of Maryland, Baltimore, the University System of Maryland, the State of Maryland, and the regents, officers, agents, servants and employees of the foregoing from payment of royalties and any and all claims arising out of or in connection with use of the Images and Story and the Program, including without limitation claims for libel, defamation, invasion of privacy, or right of publicity.
